- Reflects \$1.28M returned to the fund balance




Budget Development Process

FY 2021

- Effective July 1, 2020, Maryland Board of Public Works approved \$417M in cuts to the State's operating budget
- This means a \$130M cut to the University System of Maryland with BSU's share totaling approximately \$3.9M reduction to our State Appropriations
- University faced with losses of revenues and increased costs related to COVID-19
- Bowie State University's unrestricted FY21 operating budget is \$119M and a \$46M restricted (Grant) budget

FY 2021 (cont.)

- Current Unrestricted revenues reflect \$3M less than FY20
- FY21 budget assumes headcount of 6,171
- Tuition and fees are at same level of FY20
- No new funding for Initiatives
- Suspension of Title III conversions to State side
- Suspension of the 1% Fund Balance Goal
- Received \$1,145,210 DBM State CARES Act funds to offset expenses associated with Police/Public Safety payroll expenses



FY 2021 Budget Reduction

Academic Bond Payment Budget	\$2.2M
Vacant Positions (3 FTE's)	\$250K
Across the Board Budget Reduction 2% (Class 06-14)	\$715K
Travel Reduction 30% (Class 04)	\$260K
Temporary Salary Reductions	\$420K
Total Reductions	\$3.9M

- Utilize Plant Fund balance for Academic bond payment
- Elimination of 3 vacant positions
- Reduction to operating budgets for various departments; reduced by 2% from class 06-14 (contractual services, supplies, equipment, & fixed charges) and 30% to class 04 (travel)



FY 2021 Budget Reduction (cont.)

- Outside of the \$3.9M of reductions, we implemented a hiring freeze and will continue monitoring of spending
- Temporary salary reduction

Number of Salary Reduction Days	Average %
6 Days - Cabinet Only	2.30%
4 Days - \$100,000 and above	1.53%
3 Days - \$80,000 - \$99,999	1.15%
2 Days - \$60,000 - \$79,999	0.77%
1 Day - \$40,000 - \$59,999	0.38%
0 Days - \$0 - \$39,999	0%



Coronavirus Aid, Relief, and Economic Security (CARES) Act Federal Funds

- Bowie State University received \$6,596,246 in CARES Act funds in FY20 for the following:
 - Emergency Financial Aid Grants to Students
 - Reimbursement to Auxiliary operations for loss fee revenue (Housing, Meal Plans, Athletics, etc.)



Coronavirus Aid, Relief, and Economic Security (CARES) Act Federal Funds (cont.)

- Bowie State University received \$13,707,787 in CARES Act funds in FY21 for the following:
 - Financial Aid Grants to Students
 - Reimburse revenue loss associated with Auxiliary fees (Housing, Meal Plans, Athletics, etc.)
 - Technology
 - Instructional enhancements for remote learning
 - Other costs to address COVID-19

FY 2022

- The State is expecting revenue shortfalls in FY22
- Uncertainty on length of pandemic and long-term impact
- Resident undergraduate tuition rate increase capped at 2%
- Reinstatement of the 1% Fund Balance goal
- Reinstatement of the operating and equipment debt service costs
