## Section A: Funding Opportunity Description

### Program Overview

The Idea to Impact Graduate Research Fellowship supports high-potential graduate students conducting original summer research, creative inquiry, or applied scholarship that demonstrates clear innovation potential and meaningful scholarly, professional, or societal impact. The fellowship is designed to move promising ideas toward tangible outcomes—publications, presentations, creative works, pilot data, or externally competitive proposals.

The fellowship also serves as a leadership and professional development opportunity. Fellows will act as Graduate School Ambassadors, representing a culture of research excellence, intellectual curiosity, and interdisciplinary collaboration.

### Award Details

- Award Amount: \$5,000 (summer stipend)
- Award Period: Summer term: May 21<sup>st</sup>-August 15<sup>th</sup>, 2026
- Eligible Fields: Open to graduate students across disciplines, including but not limited to STEM, Education, Counseling, Social Sciences, Humanities, and Creative Research
- Number of Awards: Competitive; contingent on available funding

### Fellowship Expectations & Obligations

Recipients of the Idea to Impact Fellowship agree to the following:

1. **Conduct the proposed research during the summer award period**
2. **Present their work** at the Graduate School's *Transformative Synergies Conference* during the Fall semester
  - Presentation format may include paper, poster, performance, demonstration, or panel (as appropriate to the field)
3. **Serve as a Graduate School Ambassador** for the academic year following the award
  - Participate in selected Graduate School events, research showcases, or recruitment initiatives
  - Represent graduate research excellence to peers, prospective students, and external audiences
4. **Acknowledge the Graduate School's support** in any resulting publications, presentations, or creative works

5. If working with human subjects, applicants must obtain **IRB approval** before research can commence. The IRB approval must be included in the application packet.

Failure to meet these obligations may result in partial or full forfeiture of funds.

## **Section B: General Provisions**

### **Eligibility Requirements**

Applicants must:

- Be enrolled as a graduate student in good academic standing
- Have a faculty advisor/mentor who agrees to actively support the project
- Propose a project that can be meaningfully advanced during the summer award period
- Commit to presenting at the Transformative Synergies Conference

### **Eligible Grant Expenditures**

Grants may be requested for expenses, including but not limited to:

- Travel to present research or academic projects at national professional meetings
- Travel for research (e.g., data collection, archival research, research collaborations, etc.)
- Support for research and scholarly activity including equipment, supplies, photocopying, preparation of materials, software needed for research, etc.)
- IP protection of products resulting from research (copyrights, patents, etc.)

### **Ineligible Grant Expenditures**

- Ineligible expenses include university tuition and fees
- Personal expenditures

*Applicants should contact the Graduate School if there is a question regarding eligible expenses.*

## **Section C: Application Components**

A complete application consists of **five** required components. All materials should be written for an interdisciplinary audience.

## 1. Research Plan (Maximum: 3 pages)

The Research Plan should clearly articulate the proposed project and include the following sections:

- Project Title
- Research Question(s) or Creative Inquiry
- Background & Context
  - Brief scholarly or professional grounding
- Methodology / Approach
  - Research methods, creative processes, or applied strategies
- Expected Outcomes
  - Publications, performances, pilot data, presentations, prototypes, curriculum tools, etc.
- Summer Timeline
  - Clear milestones demonstrating feasibility within the award period (May 21<sup>st</sup> – August 15<sup>th</sup>, 2026)

**Evaluation Focus:** Clarity, rigor, feasibility, and scholarly merit

## 2. Evidence of Innovation Potential (Maximum: 1 page)

Applicants should explain how the project demonstrates innovation, which may include:

- Novel research questions or methodologies
- Interdisciplinary approaches
- Creative or applied problem-solving
- New uses of existing tools, data, or frameworks
- Potential to disrupt conventional thinking or practice in the field

This section should answer: *What makes this project different—and why does that difference matter?*

## 3. Statement of Long-Term Research Goals (Maximum: 1 page)

This statement should situate the proposed project within the applicant's broader intellectual trajectory. Applicants should address:

- Long-term academic, professional, or creative goals
- How this project advances future research, practice, or doctoral aspirations
- How the fellowship positions the applicant for external funding, advanced study, or leadership

**Evaluation Focus:** Vision, coherence, and future impact

**4. Faculty Mentor Support Statement** (Maximum: 1 page)

Submitted by the faculty advisor/mentor.

The statement must confirm the mentor's willingness to support the student and should address:

- The mentor's relationship to the project
- The student's preparedness to carry out the proposed work
- The mentor's plan for guidance during the summer
- The project's scholarly or professional significance

**5. Applicant Information & Certificates**

Applicants must include:

- Program, department, and degree level
- Faculty mentor name and affiliation
- Applicant CV (max 2 pages)
- Confirmation of availability during the summer award period
- Agreement to all fellowship obligations, including conference presentation and ambassador role
- IRB approval (if applicable)

**Section D: Selection Criteria**

Applications will be evaluated competitively using the following criteria:

1. Intellectual Merit & Rigor
2. Innovation Potential
3. Feasibility & Summer Scope
4. Alignment with Long-Term Research Goals
5. Strength of Faculty Mentorship
6. Potential Contribution to Graduate School Research Culture

## Section E: Submission Instructions

To be considered for the **Idea to Impact Graduate Research Fellowship**, applicants must submit **one complete PDF** containing **all five (5) required application components** as outlined in this RFA.

### Submission Steps:

1. Compile all required application materials into a **single PDF document** in the order listed in the RFA.
2. Review the PDF to ensure all sections are complete, legible, and properly formatted.
3. Email the **single PDF attachment** to [grc@bowiestate.edu](mailto:grc@bowiestate.edu) by the stated application deadline.
4. Use the subject line: **Idea to Impact Grant Fellowship Application – [Applicant Name]**.

### Important Submission Policies:

- **Multiple attachments will not be accepted.**
- **Late submissions will not be reviewed.**
- **Incomplete applications will not be considered.**
- **If stated page limits are exceeded, the application will not be considered.**
- **Human subjects research without IRB approval will not be considered.**
- **Applications submitted in formats other than PDF will not be accepted.**

It is the applicant's responsibility to confirm that all required materials are included and submitted by the deadline.
